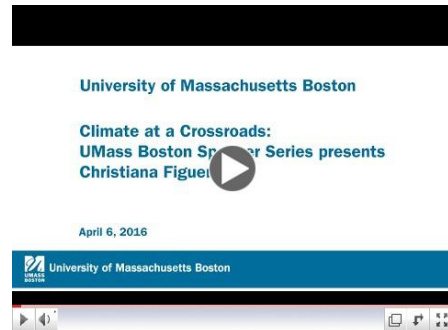




Christiana Figueres Speaks at UMass Boston
